From the Chief

To: Fire District and Board of Trustees,

It is my honor to present the Carol Stream Fire District 2023 year-end report. 2023 was another very productive year for the fire district.

In 2023, the fire district completed a series of three special meetings under a new committee called "Decennial Committee." This committee was part of a new law passed in Illinois mandating certain taxing bodies to look at their efficiency to the residents that they serve.

The fire district participated in a voluntary OSHA inspection of the policies, procedures, buildings within the fire district. OSHA concluded with positive findings and feedback.

Our fire district puts a great emphasis on fire and EMS training.

The fire district continues to be a part of the West Suburban Fire Alliance which is comprised of 6 fire departments (Carol Stream, Wheaton, Bloomingdale, West Chicago, Winfield, and Roselle). As the Alliance, we train together each month and operate under the same standard operating guidelines. In addition, we have the same responses for fire incidents, which gives us the resources needed immediately with all personnel being trained and operating the same on an emergency scene. This equates to a safer and more efficient fireground or emergency scene. It also saves money due to having the multiple resources available to the fire district right away.

Our biggest personnel change for 2023 was that the fire district hired a second Deputy Chief as part of its succession plan and to assist with the many duties that the Fire Chief and Deputy Chief are tasked with. Deputy Jason Day was hired in March. FF/PM Kevin Gay was promoted to Lieutenant and Jason Larson was hired as a new FF/PM in July.

The fire district was awarded a federal grant for two different pieces of equipment. The first was an air cascade system which is used to fill our SCBA bottles with air. The second was stair chairs which are on each ambulance and used to move patients in tight areas and down/upstairs. A third non-AFG grant was awarded for new iPads to be used for our fire investigation team conducting a fire investigation. Total amount of dollars received in grant money for 2023 was \$115,606.00.

Ordering new apparatus continues to be challenging due to long build times for the construction of fire and EMS vehicles. The fire district did take delivery of a new utility pick-up truck and new tower ladder. An order for two new ambulances was placed with a lead time of 18-24 months. The fire district continues to be aware of the long lead times and is proactively staying ahead by ordering vehicles earlier.

The fire district continued to complete improvements to our 3 fire stations. Concrete work was completed to the parking lots at Station 27 and 29. Station 28 had its original asphalt parking lot replaced.

Operationally, the fire district experienced its busiest year ever with respect to calls for service. The fire district responded to 6,387 calls from our three fire stations.

In closing, I thank you for looking over our 2023 annual report for the Carol Stream Fire District. I would like to also thank everyone who works for the fire district and makes us the best of the best by giving 100% each and every day. We strive to give our residents and visitors the best fire and EMS service possible.

Financial Summary 2023

The Carol Stream Fire Protection District utilizes a conservative budgeting process that stresses financial responsibility to its taxpayers while providing the highest level of protection and education possible.

For the fiscal year 2023, the Carol Stream Fire Protection District once again received a clean, unqualified audit from its outside CPA firm. Revenues exceeded expenses by a moderate amount, demonstrating strong management in maintaining and controlling expenses. Below is a recap of the District's revenues and expenses.

CPR

Firefighter/Paramedic Michael Fairfield

The importance of teaching CPR to the public cannot be overstated. CPR has proven to save lives for those in cardiac arrest. The Carol Stream Fire District provides limited CPR and first aid instruction to the public and businesses in the community. We have been teaching more businesses in our district than in previous years, both onsite at station 28 and off-site at the business locations.

American Heart Association Statistics

Annually, 475,000 Americans die from a cardiac arrest. Globally, cardiac arrest claims more lives than colorectal cancer, breast cancer, prostate cancer, influenza, pneumonia, auto accidents, HIV, firearms, and house fires combined. 90% of those who suffer cardiac arrest outside the hospital setting will die. However, CPR, especially if administered immediately after cardiac arrest, can double or triple a person's chance of survival.

The Personal Protective Equipment (PPE) Division is in charge of making sure all of our firefighters have some of the best and up to date turnout gear on the market to keep them as safe as possible on all incidents they respond to. This turnout gear is used for all structure fires, vehicle fires, extrications, trainings, and any other time turnout gear is needed. Gear is inspected on a biannual basis and is sent out for repairs if needed. The gear also has a life span and is on a replacement schedule for all members. This year several sets of gear where ordered and delivered to new members, and also to members needing new gear due to the gear's age. In addition to the turnout gear, the PPE division also supplies fire boots, gloves, helmets, and Nomex hoods to all members.

Station 27,28,29 Small Tools Lieutenant Dom Shurba, Firefighter/Paramedic Dan Patt, & Firefighter/Paramedic Derek Killey

- Maintained all consumables including oil dry, tarps, batteries, saw blades, saw fuel, and chains
- Maintained all tools and equipment
- Purchased equipment for the new Engine 29, including flashlights, chargers, tool mounts, and brackets
- Placed into service all new small tools on the new frontline Tower Ladder 28
- Completed annual service, inspections, and maintenance on all ground ladders, fire extinguishers, and hydraulic and E-Draulic extrication tools
- Purchased a new thermal imaging camera for the driver's position on Squad 27
- Maintained the District's meters and calibration machine by purchasing new calibrating gases and replacing sensors in the meters when necessary

Fire Investigation Firefighter/Paramedic Eric Wieringa

The Carol Stream Fire Investigation Unit (FIU) investigated approximately 27 fires during 2023; 7 Vehicle fires, 5 structure fires, 5 cooking fires, and multiple miscellaneous fires

The FIU team was able to secure a grant that incorporated iPads for our fire investigation reports. The iPads were purchased with grant money and all reports have moved to the Bomb Arson Tracking System, (BATS). This is a Federal program which tracks all fires in the nation. We are able to use the reporting system for free, and it is a much more user-friendly way to do reporting. Being a web-based program, reports can be accessed at any time, anywhere for review. Each investigator completed the required online training through CFITrainer.net. These are online training videos that test the student at the end of the program. When the test is then passed, each student gains a certain number of tested hours to use towards recertification every 4 years. Members attended outside classes as well.

Training Lieutenant Patrick Coulter

- Worked with the other members of the Alliance Training Committee to provide quick drills, company officer drills, and mandatory training for Carol Stream and the other Alliance towns
- Provided and instructed multi-company training and live-fire training at our training tower
- Worked with the chief officers to develop a direction for our training
- Worked with Target Solutions to better capture and track our training
- Conducted training with all members at two different properties where structures were being torn down

Training Tower Lieutenant Jason Kanzia

Every year the training tower strives to produce the best and most realistic training we can. This year was no different as we facilitated and hosted numerous fire departments and an impressive number of students. Carol Stream firefighters benefited greatly from all the effort put forth by those who assisted in the training tower this year. Below is a list of training tower highlights from 2023.

- Set up training tower for 2023 season, including an all hands spring clean-up
- Purchased and stored hay, flares and lumber materials throughout 2023
- Cut and stocked multiple materials for forcible entry and ventilation props
- Performed major clean up and organized training tower tools and storage room
- Performed general maintenance and upkeep of training tower, including repairs of walls and rebuild of second floor burn room
- Replaced numerous battery-powered tools to replace old tool
- Trained multiple new members to successfully participate in the training division
- Performed inspection and cleaning of both smoke generators
- Hosted 3-day Fire Behavior class taught by outside instructor
- Began fabrication of second floor roof forcible entry door prop
- Hosted 3 Alliance multi-company live fire trainings with each training reaching approximately 64 firefighter and paramedics plus numerous chief officers per day

- Hosted Special Operation Alliance trainings pertaining to:

Technical Rescue Lieutenant/Paramedic Kevin Hencinski

The Technical Rescue Team was busy sending members to Technical Rescue Classes, upgrading/replacing equipment and coordinating drills.

- Replacement of consumables (saw blades, lumber, etc.)
- Replacement of equipment that has reached the service life (helmets, anchor straps, etc.)

- Continued sending members to classes with the intention of technician level of all members






Station 27,28,29 Building Maintenance Firefighter/Paramedics Mike Kucia, Chris Molsen & Tyler Poffenbarger

Fire Prevention—Inspections Inspector Tim Ryan and Inspector Scot Neil


The Fire Chief is responsible for the management and daily operation of the Fire Prevention Bureau. The Fire Prevention Bureau is responsible for conducting life safety and code compliance inspections of all commercial and industrial businesses and multifamily occupancies within the fire district. The Fire Prevention Bureau is staffed with 2 full-time fire inspectors who strive to meet the demands of an increasingly diverse occupancy inventory and maintain knowledge of everchanging technology and code enforcement practices. There are approximately 1,567 buildings, commercial and public occupancies located within the district which are inspected on an annual or semi-annual basis.



The Fire Prevention Bureau inspection duties include:

- Annual business and multi-family dwelling fire safety inspections
- Code compliance for Fire & Life Safety Codes
- Re-inspections for code violations
- School fire safety inspections and fire drills for public and private schools


2021 ~ 2023 Three Year Comparison of Fire, Rescue & Medical Calls






2023 Calls Handled by Station









