CAROL STREAM FIRE PROTECTION DISTRICT BOARD OF TRUSTEES MEETING MINUTES May 9, 2022

President William Natick called the meeting to order at 7:00 p.m.

Roll call was taken. Present: Trustee James Panopoulos, Trustee Karl Langhammer, Trustee Richard Fisher, and President William Natick, Chief Robert Schultz, Deputy Chief Tom Nash, Battalion Chief Dave Reid, James Howard and Attorney Joe Miller. Trustee Brian Jordan was absent.

Approval of Meeting Minutes

Trustee Langhammer motioned to approve the open meeting minutes from April 11, 2022. Seconded by Trustee Fisher, four ayes on a roll call vote. Motion carried.

FY 2021/2022 Budget and Appropriations Hearing

President Natick called the public hearing to order at 7:01 p.m. on May 9, 2022.

The FY 2022/2023 Carol Stream Fire Protection District Budget has been published for at least 30 days, notifying the public of the hearing.

Trustee Panopoulos asked why there was such an increase from year over year. James Howard noted that this will be a capital-intensive year with the truck being moved in this fiscal year as well as the new engine and new heart monitors.

There being no further questions from the Board of Trustees or the Public, President Natick closed the public hearing at 7:03 p.m.

Trustee Langhammer motioned to approve Ordinance 2022-01, Ordinance providing for Budget and Appropriation of the Carol Stream Fire Protection District for the Fiscal Year beginning June 1, 2022 and ending May 31, 2023. FY2022/23 Salary Ordinance 2022-02

MSW Contract Price

Chief Schultz is requesting a 2.5% increase in the contract price for MSW Consulting for IT services. Their last increase was June 2020.

Trustee Panopoulos motioned to approve the 2.5% increase in contract price with MSW Consulting effective June 1, 2022. Seconded by Trustee Fisher, four ayes on a roll call vote. Motion carried.
