Approval of Meeting Minutes

Trustee Langhammer motioned to approve the open meeting minutes from August 8, 2022. Seconded by Trustee Fisher, five ayes on a roll call vote. Motion carried.

Approval to promote one lieutenant to Battalion Chief, one firefighter to lieutenant and hire one firefighter/paramedic.

Chief Schultz is informed the Board that Battalion Chief Reid has submitted his intent to retire October 3, 2022. With his retirement, they would need permission to promote one lieutenant to Battalion Chief, one firefighter to lieutenant and hire one firefighter/paramedic.

Trustee Jordan motioned to authorize the commission to promote one lieutenant to Battalion Chief, one firefighter to lieutenant and hire one firefighter/paramedic. Seconded by Trustee Fisher, five ayes on a roll call vote. Motion carried.

Approval of Station 28 Concrete Project

Chief Schultz and Deputy Chief Nash presented the Board with the bids for the Station 28 concrete project. A-Lamp was the lowest bid and the Chiefs are recommending the district move forward with A-Lamp to complete the rest of the project. They are estimating to start roughly within the next 30 days.

President Natick motioned to approve A-Lamp to complete the rest of the concrete project at Station 28, not to exceed the amount of \$229,327.00. Seconded by Trustee Langhammer, five ayes on a roll call vote. Motion carried.

Chief Schultz noted that BC Reid was hired in 1988 and when he retires will have been with the department for 34 years. Thee will be a huge void when he retires. We will host a retirement lunch on October 3, 2022 from 11:00 a.m. – 1:00 p.m.
