CAROL STREAM FIRE PROTECTION DISTRICT BOARD OF TRUSTEES MEETING MINUTES May 13, 2024

President William Natick called the meeting to order at 7:00 p.m.

Approval of Meeting Minutes

Trustee Langhammer motioned to approve the open meeting minutes from April 8, 2024. Seconded by Trustee Fisher, five ayes on a roll call vote. Motion carried.

Trustee Fisher motioned to approve the closed meeting minutes from April 8, 2024 and keep them closed. Seconded by Trustee Langhammer, five ayes on a roll call vote. Motion carried.

FY 2024/2025 Budget and Appropriations Hearing

President Natick called the public hearing to order at 7:01 p.m. on May 13, 2024.

Approval of Payment of Bills

Trustee Langhammer motioned to approve the Treasurer's Report for the month ending March 2024. Seconded by Trustee Fisher, five ayes on a roll call vote. Motion carried.

Approval of Transfer(s)

Trustee Jordan motioned to approve the transfer of \$2,235,180.00 from the ambulance fund to the corporate fund. Seconded by Trustee Panopoulos, five ayes on a roll call vote. Motion carried.

Trustee Fisher motioned to approved the transfer of \$350,000.00 from the ambulance fund to the capital fund. Seconded by Trustee Panopoulos, five ayes on a roll call vote. Motion carried.

Old Business

Possible approval of Station 29 Column Removal Project

Deputy Chief Day explained that there was one bid packet received in response to the bidding for the work at Station 29 and it was considerably higher than expected. He would like to go re-bid the project to see if we get more responses.

Trustee Panopoulos motioned to authorize Deputy Chief Day to re-bid the Station 29 Column Removal Project. Seconded by Trustee Langhammer, five ayes on a roll call vote. Motion carried.

firefighter/paramedic that worked here. He believes that it would be a good idea to do it and is looking for the Board's support.

Chief Schultz updated the Board regarding the new ETSB radios, they have a meeting next week and hopefully will have the radios within the next few months.

Deputy Chief Day noted that he is working with the inspections to ensure they are keeping thorough and accurate documentation. He has been looking at different companies that help with getting and keeping accurate test reports from the companies that complete the testing at each occupancy. There are other districts/departments that are currently using them.

Deputy Chief Nash explained that the bid packets for Station 27 Siding Project will go out next week, and most likely the re-bid for Station 29 Column Removal will go out as well.
