ORDINANCE NO. 2017-04

**ORDINANCE LEVYING AND ASSESSING TAXES OF
CAROL STREAM FIRE PROTECTION DISTRICT
DUPAGE COUNTY, ILLINOIS FOR 2017**

BE IT ORDAINED by the Board of Trustees of the Carol Stream Fire Protection District
as follows:

Section One: That the sum of **Eleven Million One Hundred and Eleven Thousand Four Hundred Sixty Five Dollars (\$11,111,465)** be assessed and levied from and against all taxable property within the limits of the Carol Stream Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2017. The specific amount hereby levied for each object and purpose is set forth as follows:

CORPORATE FUND

Corporate Fund Levy \$4,672,797

The foregoing amount is hereby levied for general corporate purposes pursuant to the provisions of 70 ILCS 705/14.

AMBULANCE FUND

Ambulance Fund Levy \$4,383,503

The foregoing amount is hereby levied for ambulance expense purposes pursuant to the provisions of 70 ILCS 705/22.

FIREFIGHTERS' PENSION FUND

Firefighters' Pension Fund Levy	\$ 1,258,406
Firefighters' Pension Fund Levy due to HB599	<u>\$ 218,172</u>
Total Firefighters' Pension Levy	<u>\$ 1,476,578</u>

The foregoing amount is hereby levied for public pension fund purposes pursuant to the provisions of 40 ILCS 5/4-118 and HB599.

TORT IMMUNITY FUND

Tort Immunity Fund Levy \$ 460,481

The foregoing amount is hereby levied for tort immunity purposes pursuant to the provisions of 745 ILCS 10/9-107.

SOCIAL SECURITY FUND

For Social Security Levy \$102,182

The foregoing amount is hereby levied for Social Security contribution and withholding purposes under and pursuant to 40 ILCS 5/21-110

AUDIT FUND

Audit Fund Levy \$15,924

The foregoing amount is hereby levied for audit expense purposes pursuant to the provisions of 50 ILCS 310/9.
