ORDINANCE LEVYING AND ASSESSING TAXES OF  
CAROL STREAM FIRE PROTECTION DISTRICT  
DUPAGE COUNTY, ILLINOIS FOR 2016

**BE IT ORDAINED** by the Board of Trustees of the Carol Stream Fire Protection District as follows:

**Section One:** That the sum of **Ten Million Eight Hundred Eighty Nine Thousand One Hundred Forty Two Dollars (\$10,889,142)** be assessed and levied from and against all taxable property within the limits of the Carol Stream Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2016. The specific amount hereby levied for each object and purpose is set forth as follows:

**CORPORATE FUND**

Corporate Fund Levy \$4,459,290

The foregoing amount is hereby levied for general corporate purposes pursuant to the provisions of 70 ILCS 705/14.

**AMBULANCE FUND**

Ambulance Fund Levy \$4,183,654

The foregoing amount is hereby levied for ambulance expense purposes pursuant to the provisions of 70 ILCS 705/22.

**FIREFIGHTERS' PENSION FUND**

Firefighters' Pension Fund Levy \$ 1,094,740  
Firefighters' Pension Fund Levy due to HB599 291,007  
Total Firefighters' Pension Levy 1,385,747

The foregoing amount is hereby levied for public pension fund purposes pursuant to the provisions of 40 ILCS 5/4-118 and HB599.

**TORT IMMUNITY FUND**

Tort Immunity Fund Levy \$ 748,500

The foregoing amount is hereby levied for tort immunity purposes pursuant to the provisions of 745 ILCS 10/9-107.

**SOCIAL SECURITY FUND**

For Social Security Levy \$97,069

The foregoing amount is hereby levied for Social Security contribution and withholding purposes under and pursuant to 40 ILCS 5/21-110

**AUDIT FUND**

Audit Fund Levy \$14,882

The foregoing amount is hereby levied for audit expense purposes pursuant to the provisions of 50 ILCS 310/9.

**Section Two:** That the Secretary is hereby directed to file a certified copy of this Ordinance with the Clerk of DuPage County within the time specified by law.


**Section Three:** If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of remaining portions of the Ordinance.


