# ORDINANCE LEVYING AND ASSESSING TAXES OF CAROL STREAM FIRE PROTECTION DISTRICT DUPAGE COUNTY, ILLINOIS FOR 2016

**BE IT ORDAINED** by the Board of Trustees of the Carol Stream Fire Protection District as follows:

<u>Section One</u>: That the sum of **Ten Million Eight Hundred Eighty Nine Thousand**One Hundred Forty Two Dollars (\$10,889,142) be assessed and levied from and against all taxable property within the limits of the Carol Stream Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2016.
