ORDINANCE LEVYING AND ASSESSING TAXES OF  
CAROL STREAM FIRE PROTECTION DISTRICTS  
DUPAGE COUNTY, ILLINOIS FOR 2018

**BE IT ORDAINED** by the Board of Trustees of the Carol Stream Fire Protection District,  
DuPage County, Illinois, as follows:

**Section One:** That the sum of **ELEVEN MILLION THREE HUNDRED AND FORTY THOUSAND FIVE HUNDRED DOLLARS (\$11,340,500.00)** be assessed and levied from and against all taxable property within the limits of the said Carol Stream Fire Protection District, as the same is assessed and equalized for State and County purposes for the current year, 2018, and are to be applied in liquidation of the appropriations heretofore made by Ordinance No. 2018-03 adopted by the Board of Trustees of the Carol Stream Fire Protection District, at a meeting there of regularly convened and held on November 12th, 2018 and duly published as provided by law and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

The foregoing amount is hereby levied for general corporate purposes.

### AMBULANCE FUND

Ambulance Fund Levy \$4,068,000.00

The foregoing amount is hereby levied for the purpose of providing emergency ambulance service under and pursuant to the provisions of 70 ILCS 705/22.

### TORT LIABILITY FUND

Tort Liability Fund Levy \$450,000.00

The foregoing amount is hereby levied for tort liability purposes under and pursuant to the provisions of 745 ILCS 10/9-107.

### SOCIAL SECURITY FUND

Social Security Fund Levy \$100,000.00

The foregoing amount is hereby levied for Social Security contribution under and pursuant to the provisions of 40 ILCS 5/21-110.1.

### AUDIT FUND

Audit Fund Levy \$2,500.00

The foregoing amount is hereby levied for audit purposes under and pursuant to the provision of 50 ILCS 310/9.

### PENSION FUND

Firefighters' Pension Fund Levy \$ 1,720,000.00

The foregoing amount is hereby levied for firefighter's pension fund purposes under and pursuant to 40 ILCS 5/4-118. Included in this levy amount is the sum of **\$220,000**, which is directly attributable to Public Act 93-0689 and is this exempt from the PTELL calculation.

**Section Three:** If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of remaining portions of the Ordinance.


**Section Four:** That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
